ACTION ITEMS: Phase I CCN courses

The Curriculum Committee discussed the updates to the CCN courses since our last meeting. Vivi gave some context and shared she attended an articulation meeting on Friday and the consensus was we do need to resubmit all of these CCN courses for GE approval in December. Curriculum raised questions and concerns over how they are going to review hundreds of courses from all of the community colleges in time for us to review. Josh Franco expressed concern over the review process for these courses. Vivi noted the CSU and UC system's first review the courses before they get passed on to faculty reviewers. However, they have not increased the number of faculty reviewers and this is a concern because this will take much more time on top of the regular courses that we submit for review. Vivi also noted there are conversations happening around this at higher levels. We are hoping and begging to have these before Phase 2. Josh also expressed concern over the CSU and UC's potentially using this workload increase to leverage the state and say that they need more funding. Vivi further explained we usually receive these GE approvals back in late April or early May. We are asking for more appeal leeway for these courses. Josh asked if there is a way we can communicate to the President and to Academic Senate to put pressure on state leadership. Jane noted we are having these conversations with our leadership and that we will continue to.

♦ **COMM 122:** CCN Modification, SLOs
